# ABOUT OUTFRONT MINNESOTA

OUTFRONT MINNESOTA was founded in August 1987 as a resource for queer and trans community members experiencing violence and hate crimes because of their identities. However, we soon saw that the issues the LGBTQ+ communities faced needed to be addressed with systemic change in addition to direct services.

In 1993, we successfully passed a statewide nondiscrimination law that included sexual orientation AND gender identity as protected statuses in the Minnesota Human Rights Act—the first law in the country that included protections for our trans community members. We won marriage equality by defeating an anti-marriage amendment at the ballot box in 2012 and passing marriage equality through the legislature in 2013. We ensured that our kids have safe and supportive environments to learn in by passing the Safe and Supportive Schools Act in 2014 and creating the Trans Toolkit in 2017. In 2023, we passed the Conversion Therapy Ban and the Trans Refuge Bill. Our fight is not over and our supporters are needed more than ever.

OutFront Minnesota is the state's largest LGBTQ+ advocacy organization. Our mission is to build power within Minnesota's 2SLGBTQIA+ communities and address inequities through intersectional organizing, advocacy, education, and direct support services. We envision a safe and equitable world where all members of our communities are free to lead lives of opportunity, autonomy, and full self-expression.



# OUTFRONT'S LGBTQ+ IMPACT

For decades, OutFront Minnesota has created change around LGBTQ+ rights, safety, and freedom in Minnesota. In the past five years, OutFront Minnesota:

- Secured legislative victories including the landmark Trans Refuge Bill, the bans on Conversion “Therapy” and the LGBTQ+ panic defense, updates to the Uniform Parentage Act, expanded coverage of gender-affirming care, expanded access to HIV medications and services, and more.
- Made advances in inclusive school policies across the state—including Gender Inclusion Policies in Bloomington, Duluth, Rochester, and Minneapolis Public Schools.
- Annually supported more than 5,000 educators and LGBTQ+ youth in creating safer school environments.
- Ensured the safety and supported nearly 400 LGBTQ+ victims/survivors each year of general crime and domestic violence through our Anti-Violence Program.
- OutFront Minnesota has been the #1 victims services provider for transgender and male-identified victims/survivors.





# OUR COMMUNITIES' NEEDS

In 2023–2024, Minnesota saw the greatest advances in LGBTQ+ equity in more than a decade. However, that same year national attacks against the LGBTQ+ community put extreme pressure on our community—with thousands looking to Minnesota for refuge and resources.

OutFront Minnesota is continuing to work toward:

- Shaping the national narrative around LGBTQ+ rights with local and national partners.
- Rebuilding and strengthening GSAs and our educator and GSA advisor network across the state—fostering welcoming and inclusive schools for all students.
- Ensuring the safety of more than 400 LGBTQ+ victims/survivors each year of violence by providing them with crisis counseling, system navigation, financial assistance, and advocacy.
- As a first point of contact, fielding nearly 2,000 helpline calls and directing community members to local resources.
- Defending Minnesota's advances and LGBTQ+ protections against national pressures to strip LGBTQ+ communities of their rights to live safely and openly.

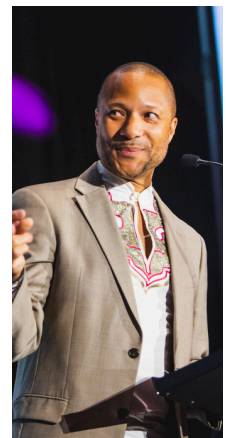
